However, in 1999, to give due importance to Tourism related activities, it was separated from Transport Department and given the status of an independent Department under allocation of business Rules 1993. Prior to 1999 Tourism Department was part of Transport Department and was separated from it w.e.f 1.8.1999. Now the Department is independently working with its own objectives and activities. The main objectives of Tourism Department are to plan for various infrastructure facilities and essential services for promoting Tourism in Delhi. Monitoring of plan and non plan scheme related to Tourism sector. Tourism Department has started a scheme called 'Paying Guest Residential Accommodation' for Tourists, which was earlier being implemented by the Regional Tourist Office of Govt. of India. The objective of the scheme is to provide affordable hygienic accommodation both for foreign and domestic tourists. Tourism Department has started a scheme called Approval of Restaurants, which was earlier being implemented by the Department of Tourism, Govt. of India. The scheme was transferred to Govt. of NCT of Delhi from July 2003. Terms & conditions/guidelines for approval of Restaurant in Tourism Department, Govt. of NCT of Delhi is enclosed. This aims at ensuring that the restaurants conform to hygienic norms and provide modern facilities to the customers. Collection and compilation of tourist statistics data from registered Hotels/Lodges/mns and Guest houses for onward transmission on monthly basis to Ministry of Tourism GOI (monthly data proforma is enclosed). Development of infrastructure for promotion of Tourism sector. Organizing of Cultural Festivals i.e. Mango, Winter Carnival Roshniara, Shalimar, Qutab Festival etc. Grant-in-aid to DTDC for strengthening of Tourist centers. Grant-in-aid to Delhi Institute of Hotel Management & Catering Technology. The institute is imparting training for degree course under the National Council for Hotel with 40 in take of students.

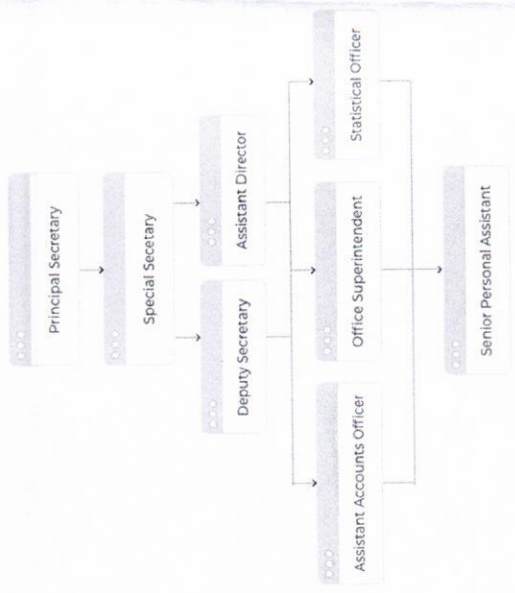

TERMS & CONDITIONS/ GUIDELINES FOR APPROVAL OF RESTAURANTS BY
TOURISM DEPARTMENT, GOVERNMENT OF NCT OF DELHI

The detailed terms & condition/ guidelines for approval of restaurants as under:-

OBJECTIVES: - This scheme is designed to accord status of approved restaurants to restaurants which are maintaining high standards. Approval certificates will be given only to those restaurants who are following the prescribed guidelines and have undergone a rigorous procedure of inspection and evaluation. The scheme is meant for giving approval to independent restaurants.

COVERAGE, PROCEDURE AND APPLICATION FORM: -

- (a). This scheme will be voluntary for the restaurants who may seek the status of approved restaurants from the Department of Tourism, Government of NCT of Delhi. However, some of the incentives given by different Departments of State and Central Government will only be available to approved restaurants.
- (b). The restaurants of minimum seating capacity of 30 persons will be covered by this scheme.
- (c). The interested restaurants may apply for approval in the prescribed application form. They should also enclose DD/Pay order as per the following scale, with the application. It should be made in favour of 'Principal Secretary (Tourism), Govt. of NCT of Delhi'.
- (i). Restaurants with seating capacity of 100 persons : Rs. 10,000/-
- (ii). Restaurants with seating capacity above 100 persons : Rs. 15,000/-
- (d). The approval will be valid for a period of 5 years.
- (e). Complete and duly filled application must be submitted in the Department at least three months before the expiry of current approval. Application fee @ 50% of the regular fee and the renewal in such cases shall be effective from the next day of the date of expiry. i.e. continuity will be maintained.

Scheme of approval of standalone restaurant should be deleted from home portal as this scheme is discontinued from this department (pdf file of order/newspapers copies is enclosed for flashing the same for awareness of general public).

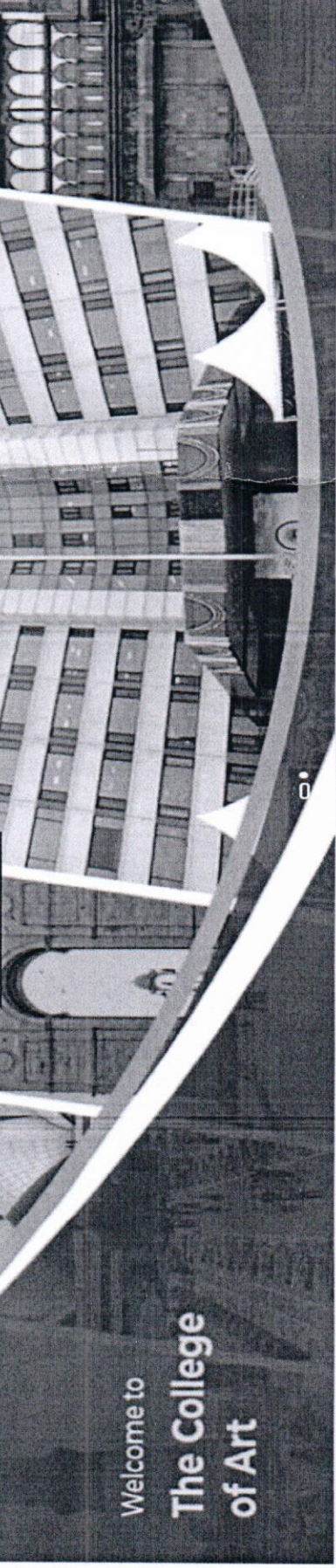
Map of Tourism Department
