3. Fo	orm and manner of applicat nent under sub-section (1) of	ion for registration.—The application for registration of residential premises as Section 3 of the Act, shall be in Form 'A'.

- (2) The fees shall be paid alongwith the application for registration by way of Demand Draft or e-Payment/online Payment in favour of the prescribed authority.
- (3) The fees paid shall not be refundable in any circumstances, either in full or in part.
- (4) In case the applicant is registered for category higher than the category which is applied for, the difference of fees shall be payable by the applicant before registration.
- 5. Additional conditions for registration.—The applicant, in addition to complying with the conditions as laid down in sub-section (3) of Section 3 of the Act, shall also,
- (a) furnish to the Foreigners' Registration Officer of the District, the particulars of any foreigner staying in his establishment, within twenty-four hours of his checking-in in the Form prescribed under the Registration of Foreigners Rules, 1939; and
  - (b) obtain and furnish at the time of registration his police verification in Form 'B'.
- 6. Constitution of the Classification Committee.—The Classification Committee referred to in sub-section (4) of section 3 of the Act, shall consist of the following namely:—
  - (a) a representative of the Tourism Department of the Government;
  - (b) a representative of the Delhi Tourism and Transportation Development Corporation Ltd.,;
  - (c) a representative of the Regional Director (North), India Tourism;
  - (d) a representative of the Deputy Commissioner of Police of the District;
  - (e) a representative of Indian Association of Tour Operators.
- 7. Checklist of services and amenities.— The checklist referred to in sub-section (7) of section 3 of the Act, shall be as in Form 'C'.
- 8. Category of establishments.—On the basis of its report, the classification Committee shall classify a registered establishment into one of the two categories, as referred to in sub-section (7) of section 3 of the Act, namely, 'Silver' and 'Gold', depending on the facilities and amenities available therein.
- 9. Form of certificate of registration.—The certificate of registration to be issued under sub-section (9) of section 3 of the Act, shall be in Form 'D'.
- 10. Form of directory of establishment.—The directory of the establishments to be maintained under sub-section (11) of Section 3 of the Act, shall be in Form 'E'.
- 11. Form of register to be maintained by the owner of the establishment.—The register to be maintained by the owner, under clause (i) of Section 6 of the Act, shall be in Form 'F'.
- 12. Period for preservation of the register by the owner.—The register referred to in clause (i) of section 6 of the Act, shall be preserved by the owner for a period of five years.
- 13. Manner for removal of the name of an establishment from the directory.—For purposes of removal of the name of an establishment from the directory under the provisions of sub-section (1) of section 10 of the Act, the prescribed authority, on receipt of a complaint from the guest(s), neighbours, police or otherwise, make an enquiry into it and examine the supporting evidence and documents and after giving a reasonable opportunity to the owner of showing cause against it, issue a speaking order recommending removal of the name thereof from the directory of establishments.
- 14. Form of notice.—The notice to be served on an establishment before removing its name from the directory under Section 11 of the Act, shall be in Form 'G'.
  - 15 Offences which may be compounded and the manner of compounding.
    - (1) Any offence whether committed before or after the commencement of this Act punishable under sections 19, 20, 21, 22, 23, and 24 may either before or after the institution of the prosecution, be compounded by such officers or authorities and for such amount as the govt. may, be notification in the Official Gazette, specify in this behalf.
    - (2) Where an offence has been compounded under sub-rule (1), the offender, if in custody, shall be discharged and no further proceedings shall be taken against him in respect of such offence.

- 16. Repeal and Savings.—(1) The National Capital Territory of Delhi (Incredible India) Bed and Breakfast Establishments (Registration and Regulation) Rules, 2007 made under Section 33 of the National Capital Territory of Delhi (Incredible India) Bed and Breakfast Establishments (Registration and Regulation) Ordinance, 2007 (Delhi Ordinance No. 1 of 2007) are hereby repealed.
- (2) Notwithstanding such repeal, anything done or any action taken under the said rules shall be deemed to have been done or taken under these rules.
